What rights am I getting with Illumina products?

The terms and conditions specific to your purchase will indicate what rights are being provided with the Illumina products. A short summary of these rights is provided below.

What does it mean for your products to be labeled for "Research Use Only"?

This means the products have not been approved or cleared for a specific intended use by the appropriate regulatory authority and are not intended by Illumina to be used for diagnostic purposes.

What does it mean for your products to be labeled as "In Vitro Diagnostic"?

This means the products have been approved or cleared for a specific human in-vitro diagnostic use by the appropriate regulatory authority.

Do you offer warranties for Illumina products?

Yes. Illumina offers warranties on consumable items and hardware. A short summary of the applicable warranties is provided below:

Type of Product	Warranty
Non-custom Consumables	Non-custom Consumables will conform to Illumina's specifications until the later of (i) 3 months from the date of shipment from Illumina, or (ii) any expiration date or the end of the shelf-life preprinted on the consumable by Illumina. In either case, the warranty will extend for no later than 12 months from the date of shipment.
Custom Consumables	Custom Consumables will be made and tested in accordance with Illumina's standard manufacturing and quality control processes.
Illumina Advantage Consumables	Illumina Advantage Consumables will conform to Illumina's specifications until the later of (i) six months from the date of shipment from Illumina, or (ii) any expiration date or the end of the shelf-life pre-printed on the consumable, but in either event, no later than 12 months from the date of shipment.
VeriSeq NIPT Consumables	VeriSeq NIPT Consumables will conform to Illumina's specifications until the later of (i) six months from the date of shipment from Illumina, or (ii) any expiration date or the end of the shelf-life preprinted on the consumable, but in either event, no later than 12 months from the date of shipment.
Hardware (Instrument)	



Hardware will conform to Illumina's specifications for 12 months after shipment from Illumina.
